B. Translation Cases

**1. BAR-18-077 Juan F. Ibarra & Margarita de Jesus
1021 East Ramsey Avenue**

- a. Request a **VARIANCE** in an “A-5” One-Family District to permit the construction of a carport that would encroach 5 feet into the required 5-foot side yard setback, creating a 0-foot side yard setback.

2. BAR-18-064

Richard Dickerson

7400 Buttonwood Drive

- a. Request a **VARIANCE** in an "A-5" One-Family District to permit the construction of a second garage, where only 1 garage is allowed on a lot less than ½ acre.

3. BAR-18-065

Lonnie Folsom

6053 Walnut Drive

- a. Request a **VARIANCE** in an "A-5" One-Family District to permit an existing accessory structure on a lot without a primary use, where accessory structures are not allowed.
- b. Request a **VARIANCE** under the "A-5" One-Family District regulations to permit a 640 square-foot accessory structure, where 200 square feet is the maximum allowed, excessive by 440 square feet.

4. BAR-18-072

Heathcote Holdings Inc. by Josh Heathcote

1909 Oakland Blvd.

- a. Request a **VARIANCE** in an "A-7.5" One-Family District to permit an existing shed that encroaches 3 feet into the required 5-foot rear-yard setback, creating a 2-foot, rear-yard setback.

5. BAR-18-074

Monica Perez by Grant Engineering Inc.

5213 Turner Street

- a. Request a **VARIANCE** in an "A-7.5" One-Family District to permit the construction of a residence on a lot that is 50-feet wide at the building line, where 55 feet is the minimum required, deficient by 5 feet.

6. BAR-18-075

Germaine Ambres

1001 Mesa Crest Drive

- a. Request a **SPECIAL EXCEPTION** under the "A-5" One-Family District regulations to permit the continued use of a 4-foot, solid fence located in the projected front yard.
- b. Request a **VARIANCE** under the "A-5" One-Family District regulations to permit the construction of an 8-foot, solid fence, in the projected front yard, when 4 feet is allowed by special exception, excessive by 4 feet.

7. BAR-18-076

DEMEC Investments by Townsite Company

5332 Gordon Avenue

- a. Request a **VARIANCE** in an "A-5" One-Family District to permit the construction of a residence on a 3,681 square foot lot, where 5,000 square feet is the minimum required, deficient by 1,319 feet.
- b. Request a **VARIANCE** in an "A-5" One-Family District to permit the construction of a residence on a lot that is 30 feet, 2-inches wide at the building line, where 50 feet is the minimum required, deficient by 19 feet, 10 inches.
- c. Request a **VARIANCE** in an "A-5" One-Family District to permit the construction of a residence that would encroach 5 feet into the required 10-foot side yard setback, creating a 5-foot side yard setback.
- d. Request a **VARIANCE** in an "A-5" One-Family District to allow 0 parking spaces behind the building wall, when 2 parking spaces are required, deficient by 2 parking spaces.
- e. Request a **VARIANCE** in an "A-5" One-Family District to permit the construction of a driveway with 56 percent front yard coverage, where 50 percent is the maximum allowed, excessive by 6 percent.



8. BAR-18-078 **Rhett Bennett by Baldwin Associates**
3867 Bellaire Circle

- a. Request a **SPECIAL EXCEPTION** in an "A-43" One-Family District to permit the construction of a 5-foot front-yard, open-design fence with 5-foot columns.


ASISTENCIA DURANTE LA REUNION PUBLICA:
