Terms and Conditions

1. Requests to reproduce images from the Fort Worth Library (FWL) Genealogy, History and Archives Department collections must be submitted in writing herein. By doing so, the applicant agrees to the terms and conditions of this document.
2. Permission to reproduce is for one-time use, for one edition, and in one language. Copies provided, including digital files, are not to be further reproduced for sale or publication other than specified herein. Digital images are not to be copied, reproduced or displayed online unless specified and approved herein.
3. Permission is limited to the applicant named herein and is non-transferable. Copies are not to be shared or given to another person or institution for any purpose.
4. The FWL reserves the right to reproduce the materials and allow others permission to reproduce the materials.
5. All use and display of any archive or other materials provided by FWL must include a credit line in close proximity to the image or in a credits section of the publication or video. Credit must be given as follows: "Courtesy of the Genealogy, History, and Archives Unit, Fort Worth Library. [Collection name, item number]". Archive collection name and item number and/or material citations [books] must be included.
6. Unless specified and approved herein, images must be reproduced unaltered. If a detail is reproduced, the caption must include "detail".
7. FWL reserves the right to deny permission to reproduce materials. Cause for doing so could include, but is not limited to, copyright regulations, physical condition of the materials, sensitivity, or privacy concerns.
8. The applicant assumes all responsibility for researching and obtaining clearance and permission from the copyright holder. FWL shall not be held responsible for copyright infringement, royalties or fees, or other improper use of the publication or use of materials. In all instances, the applicant agrees to hold the repository and its agents harmless against any and all claims arising or resulting from the use of the material and shall indemnify the repository and its agents for any and all costs and damages arising or resulting from any such unauthorized use. Patrons having questions about copyright liability should seek legal counsel.
9. In the case of works by living photographers, authors, or creators, written permission must be obtained from the original creator. The library must receive a written copy of the creator's permission.
10. The applicant must supply, without charge, one copy of the publication or work in which the materials appear to the FWL collection.
11. Failure to comply with these terms and conditions will result in withdrawal of permission to reproduce and appropriate legal action.
