SUBJECT: CCPD BOARD AUTHORITY TO TAX RESIDENTIAL GAS AND ELECTRIC USE

Residential use of natural gas and electricity is exempt from most local sales and use taxes.

However, on January 1, 2010, Section 321.1055 of the Texas Tax Code became effective, giving the boards of certain special purpose districts (SPDs) – including the Fort Worth Crime Control and Prevention District (FWCCPD) – the authority to impose the district's sales and use tax on residential use of gas and electricity within the district.

The structure of the statute vests that authority solely in the hands of the CCPD board. It does not require input from or notice to the governing body (City Council) of the municipality that shares boundaries with the district, and the statute does not allow the authority to be delegated to anyone other than the board itself.

The statute raised concerns over the newly created taxing ability residing in the hands of appointed individuals who had not been elected by taxpayers. Those concerns factored in to the decision of the Fort Worth City Council to adopt a resolution to appoint the Council's membership as the board of directors of the FWCCPD in accordance with Section 363.1015 of the Texas Local Government Code. (Resolution 3859-02 2010.)

As of August 2020, residential use of gas and electricity is not taxed by FWCCPD.

As shown in the attached chart, the Texas Comptroller's website indicates that since Section 321.1055 went into effect, twenty-two other special districts have exercised the authority granted under the statute and extended their sales and use taxes to residential use of gas and electricity. Of those SPDs, most have boards that are made up of the members of the creating city's governing body (city or town council), but three are governed by appointed boards.
