



Request for Variance to Year-Round Watering Restrictions

1. Installed at the time of the construction of a new house, new multi-family building or new commercial building.
2. Installed at the time of construction and/or repairs that alters 35% or more of an existing landscape.

Variations will not be granted for seasonal color beds or temporary grass installation (over seeding).

For health and safety reasons relating to dust control or pesticide applications.

For Athletic Fields. Sports fields, not including surrounding landscaping, may be watered as needed to maintain league standards and safety of users.

For a property that is too large to accommodate the entire area without watering during 10am-6pm.

Variance Application Checklist

In order to process your variance request, please submit the following:

- If applying for a new landscape variance, please supply a receipt for the date of purchase and installation of all plants, trees, and sod.
- A detailed copy of the proposed watering schedule showing the days of the week and watering times for each zone.
- A copy of how many stations and runtimes for the landscape.
- A detailed copy of the area that needs to be irrigated like an as-built for the irrigation system.
 - Please color code your as-built plan and/or hand drawn layout with an itemized summary attached-detailing what area is to be watered. Please include non-watered areas as well.
