- A sworn statement under penalty of perjury executed by an officer, director or authorized agent of the applicant that the applicant shall not sell, assign, or transfer by any method, the permit for the newsrack location to any other publisher, distributor, entity or individual person.
- Proof of Insurance: ...any such permittee shall be required to maintain a policy of general liability insurance in an amount acceptable to the City, naming the City of Fort Worth and its employees, agents, etc. as "Additional Insureds"...(please refer to Ordinance No. 17529-05-2007, Division IV., Sec. 30-105., J. Insurance). The minimum coverage limit for the General Liability insurance is \$500,000.

The applicant agrees to indemnify and hold harmless the City, its officers, directors and employees against any loss or liability or damage, including expenses and costs for bodily or personal injury, and for property damage sustained by any person as the result of the installation, use or maintenance of a newsrack within the City of Fort Worth. In addition, the applicant certifies that the enclosed information is correct and complete to the best of the applicant's knowledge. The applicant further certifies that they have read, understand, and will comply with all the information contained in the City Ordinance No. 17529-05-2007, adopted 5/1/07.
