- 4. Section 551.074, PERSONNEL MATTERS Deliberate the employment, evaluation, and duties of the City Manager as authorized by Section 551.074 of the Texas Government Code.
- 5. Section 551.074, PERSONNEL MATTERS
 Deliberate the employment, evaluation, and duties of the City Secretary as authorized by Section 551.074 of the Texas Government Code.
- Section 551.074, PERSONNEL MATTERS Deliberate the employment, evaluation, and duties of the City Attorney as authorized by Section 551.074 of the Texas Government Code.

- 7. Section 551.074, PERSONNEL MATTERS Deliberate the employment and duties of the City Auditor as authorized by Section 551.074 of the Texas Government Code.
