**CITY ATTORNEY**

1. Section 551.071, CONSULTATION WITH ATTORNEY

To seek the advice of its attorney about pending or contemplated litigation, settlement offers, or any matter in which the duty of the attorney to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act. [Tex. Govt. Code §551.071]:

- a. Legal issues concerning the management agreement for the Fort Worth Zoo; and,
- b. Legal issues concerning the Aaron Dean trial.

**CITY MANAGER**

1. Section 551.072, DELIBERATIONS REGARDING REAL PROPERTY

Deliberate the purchase, sale, lease or value of real property where deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third party.

2. Section 551.087, DELIBERATIONS REGARDING ECONOMIC DEVELOPMENT NEGOTIATIONS

Deliberate the commercial or financial information or the offer of a financial or other incentive to a business prospect.

3. Section 551.076, DELIBERATIONS REGARDING SECURITY

Deliberate the deployment, or specific occasions for implementation, of security personnel or devices, in accordance with Section 551.076 of the Texas Government Code.

4. Section 551.074, PERSONNEL MATTERS Deliberate the employment, evaluation, and duties of the City Manager as authorized by Section 551.074 of the Texas Government Code.

5. Section 551.074, PERSONNEL MATTERS

Deliberate the employment, evaluation, and duties of the City Secretary as authorized by Section 551.074 of the Texas Government Code.

6. Section 551.074, PERSONNEL MATTERS Deliberate the employment, evaluation, and duties of the City Attorney as authorized by Section 551.074 of the Texas Government Code.


7. Section 551.074, PERSONNEL MATTERS Deliberate the employment and duties of the City Auditor as authorized by Section 551.074 of the Texas Government Code.

C. The City Council may reconvene in open session in the City Council Conference Room and act on any item listed on the Executive Session Agenda in accordance with Chapter 551 of the Texas Government Code

D. Adjourn
