- 4. The Unclassified Excavation by Plan bid item was revised to be a fixed unit price paid by lump sum. The developer has already provided a majority of the grading per the early grading permit. It is not known how close those grades are to what is shown on the plans, so an allowance is provided for contractor's use if the completed grading is not within an allowable tolerance.
