Message from Our Assistant Director

Fort Worth Spinks Airport has officially been designated as a National Reliever Airport by the Federal Aviation Administration (FAA), marking a significant milestone in the airport's growth.

Spinks now joins a select group of just 15 Texas airports that have been recognized for their strategic significance in reducing pressure on commercial hubs and providing smoother, more efficient air traffic management. Texas hosts roughly 12% of the National Reliever Airports within the United States.

This honor highlights Spinks' expanding role in sustaining North Texas' aviation infrastructure by providing crucial services to pilots, businesses, and aviation stakeholders. This growth would not be possible without the participation of all of you. Thank you to all of our customers for helping us reach this milestone.



NE Taxiway Object Free Areas



An Object Free Area (OFA) is a two-dimensional ground surface surrounding runways, taxiways, and taxilanes. The OFA clearing standards preclude parked airplanes, vehicles, operations, and objects, except for objects that need to be located in the OFA for air navigation or aircraft ground maneuvering purposes. The OFA depicted above should remain clear of parked vehicles and aircraft at all times to ensure safe passage of taxiing aircraft.

Mind the Gates!
Please remember to stop after passing through a gate, remain present and monitor until the gate fully closes before leaving the area.

The intent is to keep unauthorized vehicles or pedestrians from gaining access to the airport.

Gate users are not expected to physically prevent passage, but your presence at the gate can serve as a deterent.

We would like to remind tenants to pay close attention to runway hold short and crossing instructions. The turf runway is expected to be reopened soon and will receive moderate usage, so expect to receive holding instructions for that runway as well. We are required to ensure read back of hold short instructions as well as the assigned runway.
