# Assistant Director's Report ~ Angela Rush, Assistant Diversity & Inclusion Director

Mrs. Rush provided the following upcoming events:

- Black History Month Reception/Open House on February 15, 2002, from 5-7 p.m., outside the City Hall Council Chambers. Some of the local organizations that will be represented at the open house include the Tarrant County Black Historical and Genealogical Society, Amphibian Stage, Kimbell Art Museum, the National Multicultural Western Heritage Museum, and Visit Fort Worth. She also encourages everyone to go to Visit Fort Worth's website, where they have numerous Black History Month events listed.
- City's Redistricting Meetings
