
#### **Active Bond Capital Projects Summary**



- Approved 2024 Tax Notes and Crime Control and Prevention District Funds for:
  - Northwest Police Patrol (CD7) \$2.7M and \$4.3M, respectively
- Approved General Fund Surplus for:
  - CFA Intermodal Parkway\* (CD10) \$2M
- Approved ARPA funds for:
  - CFA Intermodal Parkway\* (CD10) \$1M
  - North Beach St & Western Center Blvd (CD4) \$515k
  - Meadowbrook Golf Course Maintenance Bldg (CD11) \$2M
- Committed General Fund fund balance for (swap from ARPA):
  - Evans & Rosedale Mixed Use Development (CD8) \$4.2M
  - Texas A&M Innovation HUB (CD9) \$2.2M




#### **Future Library Action**

- The Downtown Library (CD9) purchase was approved August 13, 2024 and used \$6,487,008 from the Central Library Proceeds.
- Pending action for Far NW Library (CD7) will use \$3.4M. M&C forthcoming FY25, Qtr1.
- Anticipated further council item to approve the remaining \$6,047,519 in proceeds for the downtown library renovation needs. M&C date unknown at this time.

The actions above will utilize 100% of the Central Library Sale Proceeds




### **Capital Project Funding Gaps (current)**


