#### PARK INTRODUCTION

A study conducted by the City of Fort Worth in April of 2015 found that south Fort Worth required additional parkland to accommodate the population growth and community development within the area.

In November of 2015, the City of Fort Worth acquired the 67.39 –acre property south of Everman Parkway and east of Oak Grove Road as the site for the future Oak Grove Community Park. The prospective park is an opportunity to provide this area of south Fort Worth with a park that will support and enrich the dynamic vitality of the community.

The 2022 Bond Program: Proposition B Park and Recreation Improvements allocated \$3 million to the master planning, design, and construction for Oak Grove Community Park.







### PUBLIC MEETING 1 REVIEW

#### **OBJECTIVES**

Create a vital and sustainable community park.

Oak Grove Community Park will serve as a link, bringing the community together. The park will elevate and support local neighborhoods, schools, businesses, and organizations.

Conserve, respect, and represent the park system along with the priorities and dynamics of the community.

Enhance the quality of life for current and future residents.





#### PUBLIC ART PROJECT

Oak Grove Community Park is included in the Public Art Plan for the 2022 Bond Program with a total budget of \$250.000.

Guided by the Fort Worth Public Art Master Plan Update (2017), planning for the park's public art project will begin as the park Master Plan is developed.

5 to 7 community members will be invited to serve on a Project Core Team that will be closely involved with the park's public art project.






### PUBLIC MEETING 1 REVIEW

#### SITE OVERVIEW


#### **NORTH**



#### LOW MEADOW

12 -acres with large oak trees along sidewalk/street of Michael Dr. Includes the low point of the property, positioned approximately 27 ft. lower than the high point. Relatively flat (less than 1%) with 2 drainage swales. Good access to Michael Dr. and the Hamlet neighborhood.

#### **SOUTH**



#### THE KNOLL

10.7 –acres with scattered large trees (mostly Cedar Elms) and heavy underbrush. Rolling terrain with an average slope of 1.0%. High point of the property with views to the east. In good relationship to the Roy Johnson STEM Academy, located just south of the track.

#### SOUTH SLOPE

16 -acres of open rolling terrain, sloping from the Knoll to Oak Grove-Shelby Rd. at 1%.



CORNER MEADOW

3.8 -acres of relatively

flat (less than 1%) open meadow, located at the corner of Oak Grove-Shelby Rd. and Michael Dr.

### PUBLIC PARTICIPATION

#### **PURPOSE**


Engage public participation in the park planning process to receive public feedback regarding park features, clarify park priorities, and help refine the Oak Grove Community Park Master Plan in congruence with the collective community vision.

#### **METHOD**

Public participation was initiated at the 1<sup>st</sup> public meeting on September 14, 2023. A list of 9 potential park features were presented to public meeting attendees, who discussed and prioritized each park feature according to importance within the future park.

An additional opportunity for public participation came from the public survey. Comprised of 17 park features to be rated "high," "moderate," "low," or "no" priority according to importance within the future park. Printed copies of the public survey were distributed and completed by members of the public on the date of the 1st public meeting, September 14, 2023. A digital copy of the public survey became available to the public via OpenForms on September 14, 2023, and remained open for members of the public to complete online through Sunday, November 5, 2023.










### PUBLIC PARTICIPATION

#### RESULTS FROM PUBLIC MEETING 1

The graph represents the 9 provided potential park features, plus 3 additional features agreed upon by attendees for a total of 12 park features prioritized according to their value within the community park.



#### **RESULTS FROM PUBLIC SURVEY**

The data in the table represents the results from 18 paper and 46 online public survey respondents for a total of 64 public surveys completed between September 14, 2023, and November 5, 2023.


