Requests a Certificate of Appropriateness to construct a single-family home and the following waivers:

- (a) A waiver from the Driveways and Walkways Standards to allow a 12-foot wide front-entry driveway instead of the maximum of 10 feet wide.
- (b) A waiver from the Building Height, Massing, Orientation, and Setback Standards to allow a garage that is not behind a main structure, which is a site configuration that is not consistent with the configuration and orientation of the existing structures found on the block face.


**ASISTENCIA A REUNIONES PUBLICAS:**
