**DG25 – 003 1916 Delga Street (A-5 Zoning)
Downtown Urban Design District overlay, Greenway Neighborhood character zone
Council District: 11
Owner / Applicant: Marcelo Barron, Barron Services / Juan Orozco and Veronica Salazar.**

1. Request a Certificate of Appropriateness for an addition of more than 500 square feet to a single family detached home.
2. Request the following waivers from the Downtown Urban Design Standards and Guidelines:
 - a) A waiver from the Building Height, Massing, Orientation, and Setback Standards to allow a roof pitch that is inconsistent with those predominantly found on the block face.
 - b) A waiver from the Building Height, Massing, Orientation, and Setback Standards to allow a front porch with a depth of 5 feet, instead of the required minimum of 6 feet.

**DG25 – 005 1220 W Presidio Street (H Zoning)
Downtown Urban Design District overlay
Council District: 9
Owner / Applicant: Shayan Lalani, Signs Express / DFW Physicians Medical Association.**

1. Request a Certificate of Appropriateness for a comprehensive building signage plan for three canopy signs and one wall sign.
2. Request the following waivers from the Downtown Urban Design Standards and Guidelines:
 - a) A waiver from the canopy sign standards to allow three signs per canopy instead of the maximum of one sign per canopy.
 - b) A waiver from the allocation of sign area standards to allow for a 52.50 square foot ground floor wall sign, which exceeds the maximum allowable area of 35.00 square feet.
