




One incident could have multiple victims. All other offenses are based on the number of victims. It should be noted that data is subject to change.






Entertainment District Study

Safe Night LLC

- Complete on-site assessments for each entertainment district and make recommendations
- Risk Terrain Modeling (RTM) Analysis and Assessment
 - RTM identifies environmental conditions that contribute to crime problems
- Proactive Alliance Relationship-Based Policing
 - The foundation is for enforcement agencies to establish trust with business owners and the community in support of A Safe Night Out
- Develop a Bar and Restaurant Voluntary Accreditation Model
- Develop training recommendations for bar employees

Phase 1-April 1, 2024-April 30, 2024

- Preparation and pre-assessment
 - Research and begin networking and relationship building
 - In-person tours of entertainment areas

Phase 2- May 1, 2024- August 31, 2024

- Risk Terrain Modeling Assessment analysis
- Nightlife Assessment and Recommendation Report

Phase 3- September 1, 2024-November 30, 2024

- Voluntary Accreditation Model
- Data Collection to inform decisions
- Introduce New data collection criteria for city agencies


Phase 4-December 1, 2024-March 31, 2025

- Conduct 3-day training for city staff (Police, Fire, Code, Public Health, City Attorney, Planning, TABC)
- Twenty-five (25) hours of consultation for municipal agencies




PID Update

- Lacey Ruiz is a City of Fort Worth PID administrator working on this project and has personally met with business owners and residents in the area to educate them on the upcoming PID petition and attempted to get signatures
- The PID petition has been approved by legal and the city website has been updated with the most current information
- A community meeting will be held on April 17th to provide information about the PID petition





West 7th Ambassador Program




Block by Block currently provides ambassador services for Downtown Fort Worth and believe it could provide additional services for the West 7th corridor.


This 1-year pilot program has been funded by CCPD at a cost of \$315,000 with the expectation that this program will be started after a valid petition is received from the PID and these services would be transferred to the PID, once established.

- Ambassadors will be used in the area to be an extra set of eyes and ears to report criminal behavior, interact with the public, and be a visible presence
- For purposes of the pilot project, the West seventh entertainment district boundaries are West 7th St, Lancaster, University, and the rear of property on the east side of Foch



Current Police Strategies

- Traffic and crowd management strategies
- Improve lighting in the area
- A focus on self-initiated police investigation through high-volume of developed traffic stops
- Utilizing a dayshift team to focus on homeless person complaints
- An Open Container / Public Consumption ban in the West 7th Urban Village
- Pilot Program: Criminal Trespass Affidavit Program









Self-initiated Police Activity

In September of 2022, West 7th Street Unit officers began utilizing a more proactive style of policing, focusing on inbound traffic enforcement and developing traffic stops into arrests, where appropriate.

To date, the West 7th Street Unit has seized one hundred eighty-two (182) illegally possessed

weapons.

Upcoming Police Strategies

- Increase in high visibility foot patrol and bike patrols
- Installation of Flock Safety cameras throughout the area, as well as tying in existing cameras with our Real Time Crime Center
- Flock providing 10 businesses free access for Community Camera Program
- Proposed new pick-up and drop-off zones for ride-share vehicles (Uber / Lyft)
 - The proposed new zone will be on Currie Street only





Next Steps

- Execute the contract for Block by Block for the Ambassador Program
 - The Ambassadors could be in place within 2-3 weeks after the contract is signed
- Continue to work with Safe Night and the Entertainment Study
 - Continued data gathering
 - On-site/in-person visit
- Installation of the bollards
 - Installation date still being determined
- Continued Community Engagement efforts in the W 7th corridor
