

### **PROJECT SUMMARY**

ACTION:

• Curatorial Proposal Selection Process concluded on September 7, 2021.

- Selected Curatorial Proposal by curator Constance White with artists Amy Landesberg and Jessica Bell and alternate selected Curatorial Proposal by curator Iris Bechtol with artists Leticia Bajuyo and Alicia Eggert were approved by the Fort Worth Art Commission on September 20, 2021.
- On December 13, 2021, the Fort Worth Art Commission approved curator Constance White as a third artist with equal copyright to the artworks produced.
- On April 28, 2021, the original selected team (Constance White, Amy Landesberg, and Jessica Bell) informed staff that they decided to withdraw from the project due to loss of subcontractors and rising material costs.
- Public Art staff contacted alternate curator Iris Bechtol. She and alternate artists Leticia Bajuyo and Alicia Eggert are ready to move forward with their proposal pending action by the Fort Worth Art Commission.


#### STAFF RECOMMENDATION

Staff has reviewed the Curatorial Proposal and supports the recommendation for Iris Bechtol, Leticia Bajuyo, and Alicia Eggert to move forward with the project. The public art project manager (listed below) is available to answer questions prior to the meeting and at the meeting.

#### **NEXT STEPS**

Upon recommendation by the Fort Worth Art Commission, the team will be placed under three (3) separate Final Design contracts: curator Iris Bechtol will be placed under a Curatorial Consultant contract; and, Leticia Bajuyo and Alicia Eggert will enter individual Final Design contracts. The team will meet with the Project Core Team prior to developing a Final Design based on the Curatorial Proposal. It is understood that, due to rising costs since the time the curatorial proposal was developed, design adjustments may be necessary.



#### **CURATORIAL PROPOSAL**

ACTION:

Though the concepts evolved from each artist's respective practices as individuals, their work crosses paths. Each artist took interest in the circular quality of the roundabout. The roundabouts recall the shape of a clock as drivers move around them and past them, "passing time" on their daily commute. While the sculptures are stationary, their design mimics the movement of the roadway and the roundabouts, creating a rhythmic quality, like a clock ticking in time, that is both pleasing to the eye but also keeps the passer's by moving, helping to mitigate distraction.

Bajuyo's One Way and Eggert's A Very Long Now encourage the viewer to consider time as linear and endless, but also as cyclical. The spiraling up in Eggert's suggests the possibility of time extending, spiraling outward and upward. Each sculpture's placement in its respective roundabout and rhythmic quality created by repetition of elements ensures a visually engaging experience from all directions reinforcing again the aspect of time in the work. These sculptures and the relationship between the sculptures give form to the relative endlessness of time as memory and experience circle, loop, and overlap. Our proposal for the Marine Creek Parkway Public Art Project highlights our understanding of our place in the world as well as our place in time.



**PROJECT NAME:** FIRE STATION #43 **REPORT:** Project Update

### **PROJECT SUMMARY**

- Marshall Harris's Preliminary Design was approved by the Fort Worth Art Commission on February 10, 2020.
- The artist entered into a Final Design contract on March 18, 2020 (CSC 53676).
- On July 28, 2020, City asked Harris to hold on Final Design progress due to Fire Station #43's relocation.
- Harris was briefed on the new location in late January 2022. Substantial research on current costs of steel and other materials has shown is not possible to value engineer the approved Preliminary Design.

#### **NEXT STEPS**

Contract negotiations are underway for an amendment to the Final Design contract allowing the artist to complete a redesign, which will be in keeping with the themes and concepts of the approved Preliminary Design.

#### **TIMELINE**

The Final Design is expected to be presented to the Fort Worth Art Commission for approval this fall. The project is on schedule with the capital project, which is expected to be completed in Summer 2023.



Approved Preliminary Design







